## FEMA Advanced Training Modules (ATM) Announcement and Descriptions

The Advanced Floodplain Management Concepts courses are dynamic and interactive instruction intended to develop experienced Floodplain Managers in their profession.

Each Advanced Floodplain Management topic is designed to be discussed and reviewed in greater detail than the basic course. Developed and real-life scenarios will be examined and exercises will be conducted in each section to make sure participants not only understand the rules and regulations but also why they are in place and how to apply them in the particular topic areas. These courses are exercise rich and participants should expect to be actively engaged throughout.

When delivered as G courses each module serves as the base for the training. States and Chapters can add information specific to the region or trim the module if necessary to fit time constraints. Each training topic can be offered on its own or combined with any of the others.

These courses are intended for Community Officials with a Certified Floodplain Manager (CFM) designation or at least 2 years of full-time floodplain management experience as a community official. Participants should have completed E273, *Managing Floodplain Development through the National Flood Insurance Program (NFIP)*.

### **G194 Advanced Floodplain Management Concepts I**

Covers the following topics in detail:

1. NFIP Floodplain Rules and Regulations in Depth (1 day).
2. LOMC - Procedures for Applying and Floodplain Management Implications (1 day).
3. Roles and Responsibilities of the Local Floodplain Manager (1 day).
4. Preparing for Post-Disaster Responsibilities (1day).

### **G282 Advanced Floodplain Management Concepts II**

Covers the following topics in detail:

1. Higher Standards in Floodplain Management (1 day).
2. Placement of Manufactured Homes and Recreational Vehicles in the Floodplain (1 day).
3. NFIP Flood Insurance Principles for the Floodplain Manager (1 day).
4. Hydrology and Hydraulics for the FPM (1day).

### **G284 - Advanced Floodplain Management Concepts III**

Covers the following topics in detail:

1. Floodway Standards (1 day).
2. Disconnects between NFIP Regulations and Insurance (1 day).

3. Common Noncompliance Issues (½ day)
4. Digital Flood Insurance Rate Maps (DFIRMs) (½ day).
5. Substantial Improvement/Substantial Damage (1 day).
