2024 ASFPM BOARD ELECTIONS - SLATE OF POSITIONS AND INCUMBENTS

ASFPM Nomination Ballots will be sent electronically to eligible voters in February. Officers and Regional Directors nomination form/ballot will be sent to voters at the same time. Region Director seats in Regions 2, 4, 6, 8, & 10, are up for election this year so only voters living in those regions will be eligible to vote for Regional Directors. Chapter District Director seats in Districts 2 & 4 are up for election this year so only voters living in the indicated chapter states will be eligible to vote for Chapter District Directors.

All nominations and ballots will be online via SurveyMonkey. Voters will be required to enter their primary/member portal login email address in the nomination form / ballot to verify their voting eligibility. ASFPM will provide each member their primary/login email in the elections notice email along with the link to the online nomination form(s) and ballot(s).

Candidate Eligibility

All board candidates must be Individual ASFPM members in good standing to be elected, additional requirements are:

- Officers must be state government employees.
- Region Directors must not be Federal government employees and must reside in the Region they represent on the board.
- **Chapter Directors** must not be Federal government employees, must be an individual chapter member, and must reside in the District they represent on the board.

Voter Eligibility

Only ASFPM individual, honorary, and chapter members (chapter contact 1) in good standing are eligible to vote in board elections, additional requirements are:

- All eligible voters may vote for Officers.
- Only ASFPM members from Regions up for election may vote for their Region Directors. Voters may only vote for Region Director Candidates from and representing the voters' own Region.
- Only ASFPM members residing in chapter states within Chapter Districts up for election may vote for Chapter Directors.
 Voters may only vote for Chapter Directors Candidates from and representing the voters' own District.
