# **New Work Items:**

- Provide comments/feedback to the <u>No Adverse Impact Committee</u> for the "<u>How-to Guides</u>" focusing on Mapping and Hazard Identification and Higher Regulatory Standards.
- 2. Provide comments and recommendations for the condensed version of ASFPM's "National Flood Programs and Policies in Review."
- Continue to complete the "Riverine Erosion Hazard Discussion Paper" for public use and explore the possibility for it to become a White Paper for adoption by the board.
- 4. Begin and develop the second in a short series of discussion papers with NBF-related content, following up on the Riverine Erosion Hazard discussion paper.
- 5. Support and provide content and feedback to ASFPM Science Services as they update and evolve the ASFPM committee web pages.
- 6. Explore the possibility to partner with the APA's Water Task Force to help promote their key recommendations.
