4.1: Conference Calls and Committee Retreat

4.2: ASFPM Annual Conference

- Status: Bob reporting:

Proposed Peer Review Draft Letter

Subject: ASFPM supporting a peer reviewed journal in floodplain management.

The Higher Education Sub-committee feels strongly that the field of floodplain management would benefit from a Peer reviewed journal. The discipline is sufficiently mature with their being the appropriate interest in support and contribution to support publication.

However, the sub-committee recognizes such a venture is complex involving many stakeholders and will require significant resources. We are not taking these obstacles lightly and with an understanding of the effort required we offer the following. The following is based on preliminary review by the sub-committee. Ideally, a more intensive effort may be required to develop this proposal further after taking the preliminary decision on what route to consider for publication.

Before we proceed any further, we would like some indication from the Association as to which path they would prefer:

- 1. Self-Publish,
- 2. Partner with an existing publisher such as Wiley Press, or
- 3. Partner with an existing journal that has an existing journal such as APA.
